

Products, sales, and services agreement for all websites, social media platforms, and other outlets for Kingdom Talks Media and our guests, affiliates, and partners.

The term guest, guests, affiliates and or partners refers to anyone allowing or asking that their products be posted, marketed, and/or sold from any and all of Kingdom Talks Media's platforms.

Guests and Their Products Advertised on Kingdom Talks.

Having a guest on any platform and promoting of a guest's products does not mean Kingdom Talks Media agrees with any or all the material presented.

1. This agreement will be in effect for guest's products on any or all of Kingdom Talks Media platforms.
 - A. **Digital and/or online courses – Finished products** that are fully prepared by the guest and need only to be connected via a link or download.

Kingdom Talks Media will receive 33% of revenue on all sales from our platform. 67% will go to the guest.
 - B. **Digital and/or online courses created by Kingdom Talks Media** (i.e. Setting up a sales platform, filming, editing, etc.)

Kingdom Talks Media will sell from our platform and will receive 66% of revenue generated. 34% will go to you as the guest.
 - C. **Merchandise being sold** – Kingdom Talks Media will receive 20% of net profit from merchandise sold as a result of promoting from Kingdom Talks unless otherwise agreed. This will be left to the guest to determine and will be based on honor and integrity.
 - D. **Monthly subscriptions** – Kingdom Talks Media and guest must have an agreement in writing/email. Each subscription will be on a case by case situation. At a minimum Kingdom Talks Media will receive the first month subscription price from any subscriptions sold. This, too, will be left to the guest to determine and will be based on honor and integrity.

Kingdom Talks Media has the right to all that is said or done via audio and/or video on **Kingdom Talks Shows**. We reserve the rights to all shows on our platforms and may remove or retain all video, images, and audio on any of our platforms at our own discretion
